During his years of practice, Mr. Kimmelman acted as lead counsel in international commercial arbitration and investor-state disputes and served as an arbitrator in international disputes. He currently serves as Chair of the New York International Arbitration Center.

Floriane Lavaud is a member of Debevoise & Plimpton LLP's International Dispute Resolution Group in New York and Paris. Her practice focuses on public international law, international arbitration, and complex litigation, with a particular emphasis on the Middle East.
